AOB	SD asked EJ to voice her issue first EJ – [Parent of player and Wife of former coach DJ]. DJ received a letter on 10 <sup>th</sup> Sep informing him that he had been suspended. DJ had not received a reason why; a timeline or identification of the process. SD had not acknowledged the voice mail. EJ raised concern about Safeguarding / Confidentiality issues: Phone calls to parents including "we were led to believe" – which is what DJ thought to be correct at that time; EJ mentioned that the correspondence therefore contained 'slanderous' comments. DJ's effort to create a merger team was done in good faith. The committee have not followed due diligence. EJ defamation of character; called into question DJ's integrity and called him a "liar". DJ feels that he hasn't been spoken to openly.  2 <sup>nd</sup> issue is 'parental' – in emails sent on 10 <sup>th</sup> and 14 <sup>th</sup> Reg 15 states "in order for teams to merge; children must be assessed by Level 2 Coach and Parental Consent forms must be signed. EJ feels that FRFC are, on one hand putting blockers in the way of joining Faringdon but on the other hand are not following due diligence process in managing the merger of the U15s and U16s teams.  I would like you to discuss where the Safeguarding and Confidentiality went wrong and where the consent from Parent's came from.  SD – first response from DJ was "we're leaving the club". SD expressed; directed by GRFU to suspend DJ. out at GRFU level: advising RFU. Had there been a conversation; that investigation may not have happened. EJ mentioned that LP sent letter on 6<sup>th</sup> March regarding alleged breach of Line Out contested regs – which EJ mentions DJ taught in training only – which is in conformance to regs. EJ raised concern that the club did not acknowledge or conclude that - no response from training record. EJ mentioned that the lack of organised fixtures triggered the situation where parents took the planning of fixtures into their own hands - which felt like it created a "them and us" atmosphere. The choice to leave FRFC was therefore not a snap decision. SD voiced concern of committee that DJ has continued WhatsApp group – EJ is the Admin of that group. EJ stated that the committee cannot decree who can or can't create a WhatsApp group for parents. LP raised concern about possible Safeguarding issues DB mentioned that he had seen comments in a Parent Group that were "out of order". LP explained that; the club are entrusted to assure child safety, Some teams have arrived without the Committee's or the Facility's Manager's prior knowledge. EJ stated that it was on Spond; GE was not aware because food was not required. LP continued that the club had made great progress towards bringing that team back into line with FRFC and she had contacted Faringdon – who confirmed that Faringdon actually have an U16s team with a minority of U15s playing. SD explained that there is a difference Permission granted to merge on Friday (16<sup>th</sup> Sep) – so when letter to parents went out on Thursday – FRFC had no proof of that merger having been granted by the RFU

EJ mentioned that two children who have left are still receiving



	emails. EJ feels that the committee have gone about this "the wrong way" and that there is no clarity about who is doing the investigation or what the closure timeline will be.
